Designed as a one-step fertilizer application for all in-ground and container growing.

Commercial Suggested Applications: We suggest a materials compatibility test determined from soil, plant tissue analysis or sap analysis per fertilizer program. When used as directed, All-Purpose fertilizer is compatible when mixed with substrates including potting soil, manure, peat moss, coir and paper. Instructions: Blend All-Purpose powder into substrate and mix well. When blending the All-Purpose powder with materials that may contain moisture, including manure or potting soil, it is best to use within 2 days. If mixed with dry substrate materials such as peat moss, coir or paper products, the mixture can be stored for up to 6 months. After all applications, water plants generously. For indoor and outdoor use year-round.

Compatibility: All-Purpose is compatible with most fertilizers, plant nutrients and pest control products. For best results, it is recommended that a physical and plant compatibility test be conducted before use.

Storage: Store in a cool, dry place away from moisture. Tightly reseal opened bags or sacks.

Expiration: Official OrganicsRx products when stored correctly can be applied for up to 2 years from the purchase date.

Handling: Official OrganicsRx products are non-toxic and considered safe when in contact with skin. Wash exposed skin after prolonged handling with warm soapy water. May be harmful if swallowed. Not for human or pet consumption.

Home Garden & Greenhouse Suggested Applications: For potted and in-ground vegetables, herbs, fruit, flowers, trees, turf and orchids. Instructions: Apply 1 teaspoon of All-Purpose powder per 8"-12" container. Sprinkle directly at root base and gently blend. When mixing in larger batches, add 2 heaping tablespoons of All-Purpose powder per 8 pounds of substrate and blend well. When mixing the All-Purpose powder with substrate materials that may contain moisture including manure or potting soil, it is best to use within 2 days. If mixed with dry substrate materials such as peat moss, coir or paper products, the mixture can be stored for up to 6 months. After all applications, water plants generously. For indoor and outdoor use year-round.
